- Technical Due Diligence on academies joining the MAT to ensure all condition and compliance issues and liabilities are identified.












Condition and Compliance Surveys

A Condition and Compliance Survey is an important tool for any school or academy to understand its estate and the priorities that need to be addressed through future capital investments. Surveys are undertaken by surveyors with significant understanding of educational sites who advise on the timing and potential cost of replacements and improvements.

Our Condition and Compliance surveys provide:

- A full Building Condition Survey undertaken by Chartered Building Surveyors with the option for safe roof access if required.
- A consultation with stakeholders to obtain background knowledge on condition issues and past capital investments.
- A full review of all compliance documents to establish if there are any gaps.
- Recommendation of Mechanical, Electrical and Structural Consultants if required for specialist inspections.
- The option of providing you with updated site drawings and floor plans.
- Survey data provided in user friendly formats with priority ratings in line with the DfE Condition Data Collection guidance and cost estimates for budgeting purposes.


